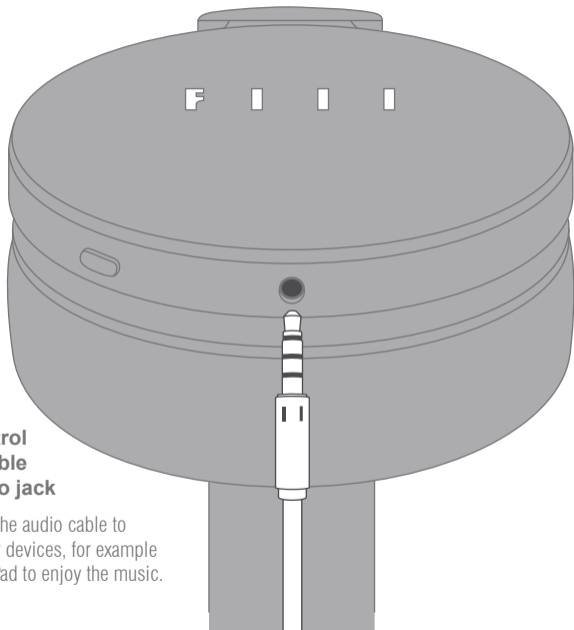

- Connect the other end of the audio cable to the output of music player devices, for example mobile phone, MP3 and Pad to enjoy the music.

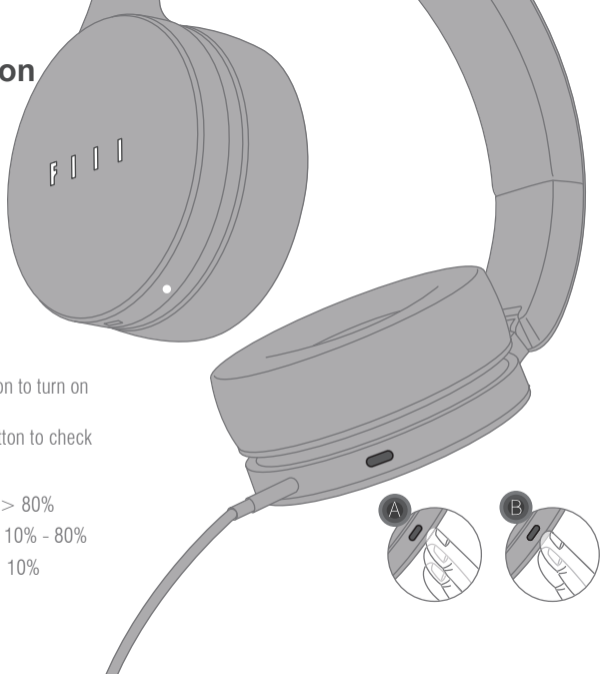
Active Noise Cancelling (ANC)



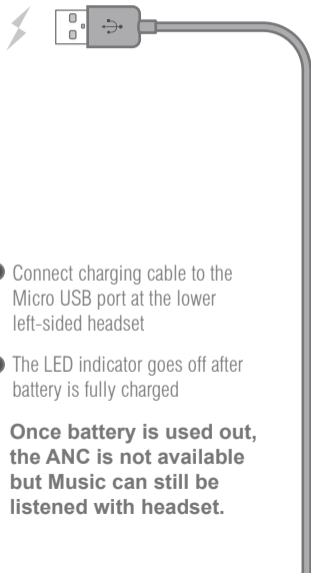
- **ANC is Off by default when out of box.**
- **A** Short Press the ANC button at the lower right-sided headset to turn ANC on/off,
- **B** FILL Logo indicator briefly breathes once;
- **C** Once ANC is activated, the LED indicator at the lower left-sided headset will be constantly on.

Battery Indication and Turn on Fiil Logo

- A** Triple Press the ANC button to turn on or off the Fiil logo light
- B** Double press the ANC button to check the battery level
- Blink Green: battery level > 80%
- Blink Yellow: battery level 10% - 80%
- Blink Red: battery level < 10%



Charging Headset

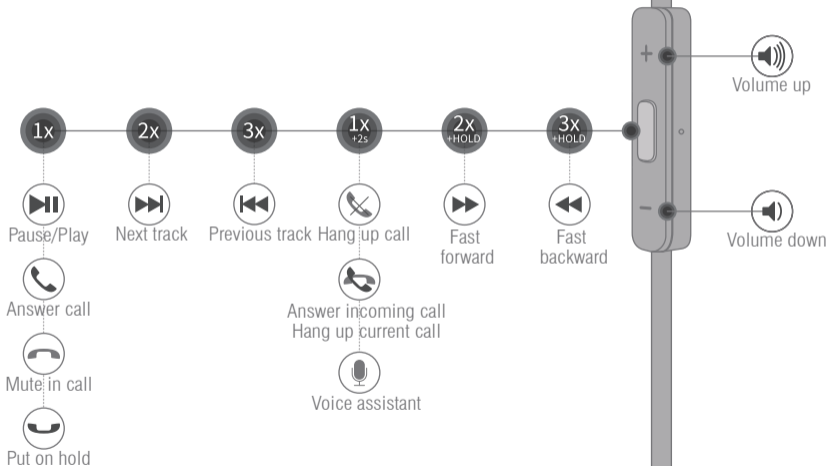


- A** Connect charging cable to the Micro USB port at the lower left-sided headset
- B** The LED indicator goes off after battery is fully charged

Once battery is used out, the ANC is not available but Music can still be listened with headset.

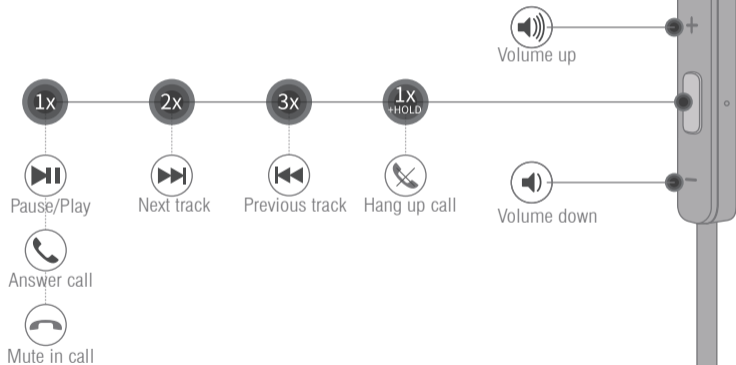


Inline Control - iOS System



Inline Control - Android System

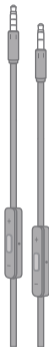

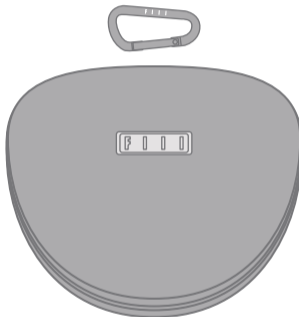
